## Resolution Dissolving the Solid Waste Management Committee and Creating the Materials Management Planning Committee – DPW/Solid Waste

- WHEREAS, the Livingston County Solid Waste Management Committee was created via Resolution 2018-04-060 under the provisions of Part 115 of Act No. 451 of the Public Acts of 1994, as amended; and
- WHEREAS, the Solid Waste Management Committee exists to assist with updates to the Livingston County Solid Waste Management Plan and to make recommendation to the Board of Commissioners for proposed amendments to the Solid Waste Management Plan; and
- WHEREAS, recent amendments to Part 115 went into effect on March 29, 2023 and require that all counties prepare a Materials Management Plan, which after approved will replace the Solid Waste Management Plan; and
- **WHEREAS,** the amendments to Part 115 require that a Materials Management Planning Committee be appointed with representatives from specific sectors; and
- WHEREAS, these specific sectors are: 1. Solid waste disposal facility operator 2. Managed material hauler 3. Materials recovery facility operator 4. Compost or anaerobic digester facility operator 5. Waste diversion, reuse, or reduction facility operator 6. Environmental interest group 7. Elected official of the County 8. Elected official of a township 9. Elected official of a city or village 10. Individual that generates a managed material 11. Regional planning agency (SEMCOG) 12. The county may appoint one individual representative that does business in or resides in an adjacent community outside the planning area; and
- **WHEREAS,** the Materials Management Planning Committee will primarily assist in the development and implementation of the Materials Management Plan in addition to its other responsibilities under Part 115.
- **THEREFORE, BE IT RESOLVED** that the Livingston County Board of Commissioners hereby dissolves the Livingston County Solid Waste Management Committee.
- **BE IT FURTHER RESOLVED** that the Livingston County Board of Commissioner hereby establishes the Livingston County Materials Management Planning Committee as a permanent body in accordance with Part 115, Solid Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.
- **BE IT FURTHER RESOLVED** that members of the Livingston County Materials Management Planning

  Committee shall be appointed pursuant to Livingston County's committee appointment policy.
